As agreed in our meeting at MCB Camp Lejeune on 19 and 20 February 1992, we will revise the Draft Final Site Assessment Report for Sites 6, 48, and 69 and submit the document as a "Final Interim Site Assessment Report". In your letter of 2 January 1992 you stated the EPA considered the subject document a secondary document, in light of the upcoming RI/FS work at the subject sites, for which (at that time) you were reviewing the Draft Project Plans. You further indicated in this letter that the EPA would not issue approval or conduct further review of the subject documents. Accordingly, the Final Interim document will include appropriate text revisions in response to comments received from the NCDEHNR (letter dated 19 February 1992).

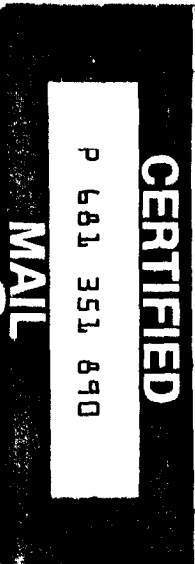
